In the **"Scientific Studies Section"**, we first present the article titled **"Ethical Evaluation of Complementary and Alternative Medicine Practices"** of **Sevim Coşkun** and **Nüket Örnek Büken**. In this article, the authors include explanations that will clear up the confusion regarding the concepts of traditional, complementary and alternative medicine. In this context, we think that this comprehensive article, which deals with why complementary medicine (TAM) practices are applied, the approaches of modern medicine on these applications, TAT applications and legal regulations in our country, will shed light on the solution of the problems in the related subject.

Hilal Yaşar and Deniz Say Şahin evaluate the causes of the disadvantages of elderly individuals through the concepts of aging, gerontology and geriatrics in their article titled "Characteristics of Old Age and the Elderly Individuals as a Disadvantaged Group in Turkey: From Wisdom to Addiction". The authors, who touch on health problems, economic problems and psychological problems related to the old age period, present a very rich content about elderly individuals, whose vulnerability is even more important in situations such as pandemics.

Özge Kutlu Dönmez and Deniz Say Şahin address the role of social service practices in their article titled "The Elderly and the Role of Social Service in the COVID-19 Pandemic", considering the devastating effects of the COVID-19 pandemic, especially on the elderly. These days, when we better understand the importance of social service practices during the pandemic, the article offers worthy of knowledge and evaluations.

Hilal Yaşar explains the concepts of childhood and children's rights in the context of gender in her second article, titled "Children's Rights and An Evaluation of Child Rights Violations", and evaluates the violations and problems experienced.

Özge Bayram and Deniz Say Şahin define child spirituality with a comprehensive spirituality framework in their articles titled "The Relationship Between Childhood Traumas and Spiritual Well-being". They explain the first, second and third group reactions to traumatic processes through the concepts of childhood and trauma. The article has been prepared quite comprehensively including the assessment that a protective factor will be created against the negative situations that occur after the trauma, with the development of the child's spiritual ability,

Sema Coşkun, Ph.D. student at Hacettepe University Graduate School of Natural and Applied Sciences, Department of Bioengineering, in her article titled "Overview of Ethical Issues in Bioengineering", makes a general analysis on ethical issues in many sub-fields of bioengineering and makes evaluations on the identification of possible ethical problems.

In her article titled **"Gender Equality and Participation in Politics", Sevinç Sütlü** analyzes gender-based differences and progress in the light of the global gender gap index data. In this context, the author touches upon the legal regulations in our country and presents his views on increasing participation, together with evaluations on the factors that prevent women's political participation.

Associates of our department, **Assoc. Prof. Önder İlgili** defines an emerging need that is often forgotten in his article titled **"Definition of a Need: Mobile Phone and Information Systems Etiquette Rules".** The article has meticulous evaluations on the innovations that technology has brought to our lives, including opinions, suggestions and wishes for our purposes in the ethical evaluation and guidance process.

In the activities section, information about the "**Bioethics and Cinema**" event, which is held on **Thursdays** in the context of continuous professional development, is presented. Those who want to participate in the organized events can contact the secretariat of the Department.

In this issue, as always in our **"Interview Section"**, we will read another one of the valuable contribution from an associate of Department of History of Medicine and Medical Ethics, **Lecturer Müge Demir**.
